## Application

Task	Method	Dilution
Bathrooms and change rooms	1. Spray one squirt high into the air, or for a longer residual effect spray directly onto an inconspicuous surface such as the toilet cistern behind doors. In Saunas, spray onto the underside of timber seating and allow to penetrate.	Use Neat - Undiluted
Carpet deodorant - professional use	1. Spray 4 Squirts per room (approx. 4.5 x 4.5 m) over the carpet prior to pre-spraying with CITRAFRESH or SPITFIRE. Extract with hot water as normal. 2. This method allows APEEL to be in contact with all of the carpet fibres. 3. On completion of the room spray once or twice into the room to complete the residual effect.	
Hospitals, motels, hotels	1. To combat stale smoke, alcohol or odours, one squirt per 20m <sup>2</sup> is enough. 2. If odours are strong, lightly apply APEEL to curtain backing. 3. Hospitals successfully use APEEL where incontinence causes problems.	
Industrial waste (compactors/garbage bins)	1. Spray over compactor or waste storage bins. Best results are obtained by spraying after cleaning or removing excess waste.
